NOTICE OF INTENT TO APPLY UPDATE: COMMISSION RECEIVES EIGHT NOTICES OF INTENT FROM EIGHT NONPROFIT ORGANIZATIONS

Commission provides an update on first step in application process

The Washington State Charter School Commission (the Commission) has received a total of eight (8) Notices of Intent (NOI) to apply from eight (8) nonprofit organizations. The organizations represent a broad swath of Washington State communities, and intend to submit applications for schools in the following communities: (Proposed School Name, Grades to be served, and community served)

- Academy of Empowerment, Kindergarten through 8th, Federal Way
- Bilingual Charter Academy, Kindergarten through 8th, Clark County
- Kenneth G. McLendon Sr. Creative Academy, 6th through 12th, Lynden
- mStar Academy, Kindergarten through 12th, Tacoma
- PHASE 4 America Charter School, Kindergarten through 12th, Seattle/Tacoma
- Summit Public School: Seattle #2, 6th through 12th, Seattle
- Tacoma Preparatory Academy, 9th through 12th, Tacoma
- Willow Public School, 6th through 8th, Walla Walla

Of the eight, two have submitted applications previously, Summit Public Schools and Bilingual Charter Academy.

The Commission welcomes the new and returning applicants in their efforts to demonstrate how they intend to improve educational outcomes for at risk students. The applicants can now look forward to completing comprehensive application that is due May 15, 2015, as well as engaging in in-person interviews in late June, and attending a public forum in late July. The Commission will vote on which applications to approve during its August 13, 2015 meeting at the South Seattle Community College, Georgetown Campus in Seattle, WA.
