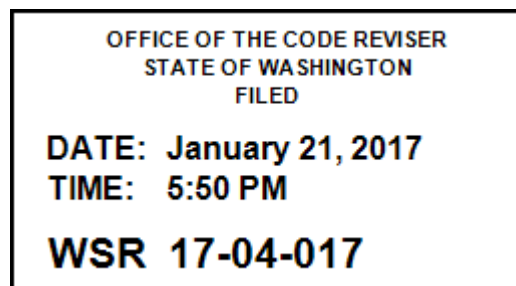
Re: Updating Agency Rules
